About the Mentorship

Thank you for your interest in the Safe Passage Mentorship Program!

Safe Passage is Kentucky's frontline responder to the issue of child trafficking. We provide empowering mentorship and support services to youth who have experienced sexual trafficking, exploitation, or grooming. The ability to match youth is based on the number of mentors available- *which is why we need you!* There is a youth survivor who needs a supportive and encouraging mentor in their life. **Help us empower youth to leave sexual exploitation, sustain freedom, and believe in a hopeful life ahead; with the support of a mentor.**

WHY MENTORSHIP?

Children are sexually exploited every day. Unfortunately, trauma can impact every area of life. Dreams, goals, self-worth, trusting people, and finishing school can all feel out of reach after exploitation. *Mentorship* is a powerful way to encourage, empower, and walk alongside trafficked and exploited youth.

The Safe Passage Mentorship uses an empowerment and strengths-based approach that is rooted in TBRI (Trust Based Relational Intervention) principles.

Mentorship is a <u>restorative relationship</u> that:

- Encourages growth and healing
- Creates social support and connection
- Exemplifies healthy relationships, boundaries, and trust
- Affirms worth and potential
- Cultivates confidence and self-esteem
- Connects youth to new experiences and opportunities
- Furthers education and career development
- Challenges and expands worldviews
- Uncovers and supports dreams and goals
- Helps survivors to reconnect with laughter, joy and fun

The Safe Passage Mentorship is for youth ages 12 - 19 years old who have been impacted by child trafficking, exploitation, or grooming. We serve boys and girls, and have need of male and female mentors. We need mentors in Louisville, New Albany, Lexington, and everywhere in between.

Mentor Description

Mentor Role

The mentor's role is to be an encouraging role model who gives the youth a safe, non-pushy, and non-judgmental place to heal and explore their hopes for life. A mentor with Safe Passage builds a relationship based on trust and acceptance with their mentee, which provides a foundation for growth and healing.

Supported by

Mentor Coach and Mentorship Coordinator

Time Commitment

The average mentor spends approximately 3-7 hours a month participating in mentoring activities. Some mentors see their youth once a week, others see their youth twice a month. We know life happens but we ask you to try to see your youth at least twice a month so they know you are consistent in their life.

Qualifications of a Mentor

- ★ Strong relationship with Christ, strongly rooted in the Word
- ★ Living a pure life (sexual purity, waiting for marriage, free from pornography, etc.)
- ★ Be at least 21 years of age living in region in which applied
- ★ Have a desire to build a genuine and caring relationship with a survivor of exploitation
- ★ Must have a schedule that will allow you to meet consistently with a youth
- ★ Must be highly coachable, able to receive constructive feedback that will help you grow stronger in your relationship with your mentee
- ★ Must be a natural in interacting with teenagers
- ★ Be connected to a healthy support system (church, family, friends, etc.).
- ★ Must not be easily triggered- this is an intense mentorship opportunity with exposure to secondhand trauma
- ★ Must not be easily disappointed- youth are still living a life on drugs, running away, selling their bodies, cutting people out, etc.
- ★ Have a valid Driver's License, access to an automobile and auto insurance
- ★ Must be willing to submit reports to your Mentor Coach and work with the Safe Passage team to ensure a healthy, flourishing mentorship

Volunteers are not suitable for mentoring if they:

- Have been cited for driving under the Influence (DUI) within the last 5 years.
- Have been involved in a crime against a vulnerable person (child, disabled adult). Those with any other past criminal record should speak with the Safe Passage Mentorship Team.
- Plans to move out of region within one year of the start of the 1:1 mentoring relationship
- Cannot complete their mentor commitment. (Studies show that if a mentor quits before their commitment is up it does harm to the mentee.)

Matching

- Matching mentors with a youth is much like signing up to become a foster care parent- We never know what will happen or when we will receive a call. Due to this, we cannot give new mentors exact timing on when they will become matched after training. This will be further explained during your interview.
- Once a youth is identified to become matched with you, it is important to know that timeliness is a *high priority*. Many of these youth are in situations where life can change on a dime- so when we are ready to match you, we have to move quickly to meet the youth while the door is open.

Statement of Faith

- 1. We believe that each person has the right to accept or deny the claims of Jesus, and that our obligation to meet their needs is not contingent upon their decision.
- 2. We believe that the best expression of Jesus Christ to those who do not know Him is to hear the claims of Jesus in the context of genuine love and compassion tangibly shown through the meeting of their needs.
- 3. We believe the Bible is fully inspired by the Holy Spirit, entirely reliable, truthful and stands as the authority over our lives.
- 4. We believe that God exists eternally as three persons who share the Divine nature. The Bible refers to these persons as the Father, the Son, and the Holy Spirit.
- 5. We believe that Jesus Christ, as the Son, is fully God and fully man. Come to us by the virgin birth, He lived a sinless life, died on the cross for all the sins of mankind, was resurrected bodily on the third day after His death, and later ascended into heaven. He is coming again as both Judge and King.
- 6. We believe that salvation consists of reconciliation with God and is available to all humanity only through the atoning death of Jesus Christ. Salvation is received through God's grace as a gift whenever a person places their complete faith in the saving work of Jesus Christ.
- 7. We believe that all humans are created in the image of God, and as such have inherent dignity and worth. Because of the abuse of our free will though, all humans have become separated from God and live in alienation to God until they receive salvation through faith in Jesus Christ.

Statement of Marriage and Sexuality

We believe in providing the opportunity of restoration (Luke 4:18-19) and redemption (Luke 19:10) for child victims of trafficking (John 8:3-11). We believe freedom (John 8:36) and healing (Luke 4:18-19, Psalm 147:3) occurs for the victims of trafficking because the love (1 John 4:19) and power (1 Corinthians 1:18) of Jesus brings genuine transformation (2 Corinthians 5:17). Since the trauma is sexual in nature, human sexuality must be stewarded with seriousness and compassion. For this reason, Safe Passage affirms the following beliefs and practices in the area of sexuality.

We believe that God wonderfully creates each person as either male or female as acknowledged at and even prior to birth, and that these two distinct, unchanging, and complementary sexes together reflect the image and nature of God. (Genesis 1:26-28) We also believe that God created marriage to be exclusively the union of one man and one woman in covenantal relationship, and that God intends intimate sexual activity and sexual intimacy to occur exclusively within that union and covenantal relationship.

We believe the dignity of each individual is upheld by embracing the unchanging principles of Scripture which affirms the worth of all humanity (1 Timothy 3:16-17). Worth is upheld by treating each person with respect, compassion and sensitivity as image-bearers of God regardless of their beliefs or conduct (Genesis 1:26-27, Psalm 8). We believe that the Bible speaks to belief and behavior concerning human sexuality, providing guidance to understand and articulate these matters. The Bible celebrates two options for human sexual conduct: marriage as a covenantal relationship of one man and one woman in which sexual intimacy is expressed (Genesis 1:27-28, Genesis 2:18-24, Matthew 19:4-9, Mark 10:5-9, Ephesians 5:31-33) and celibacy as faithful singleness to abstain from sexual intimacy (1 Corinthians 7, esp. 7-9 & 32-40, Matthew 19:10-12). Accordingly, all forms of sexual intimacy outside of these boundaries are sinful and destructive to human relationships (1 Corinthians 6:18-20, Hebrews 13:4).

Because Safe Passage serves and ministers to persons victimized by trauma of a sexual nature, human sexuality must be stewarded with seriousness but also with compassion. Accordingly, we believe that all forms of sexual activity or sexual intimacy outside of the boundaries and beliefs set out herein or inconsistent with the boundaries and beliefs set out herein are sinful and destructive to human relationships. We believe that the values and integrity of Safe Passage will be preserved through the agreement of those who serve within the organization with this statement (1 Corinthians 1:10, Ephesians 4:1-7, Proverbs 29:18).
